AAPOR Committees

- Committees are the backbone of AAPOR's structure as an organization.
- Committees are charged with specific tasks that keep AAPOR running throughout the year.
 - The mandate for each committee comes from the Executive Council.



AAPOR Committees

- Committee Structure
 - Each committee is led by a chair and associate chair.
 - Most committees are made up of subcommittees, which are more focused on individual parts of the committees mandate.
 - Each subcommittee is led by a chair.
 - Each member of the committee serves a three year term, with the option to serve a second term.
- Time commitment for committee work varies by committee.



Subcommittees

- Subcommittees allow committee work to be divided and for interested members to work on a specific project
- Examples:
 - Social Media subcommittee of the Communications
 Committee
 - Student and Early Career Engagement Subcommittee of the Membership and Chapter Relations Committee

Committee Appointment Process

- Committee members are nominated by committee chair
- Nominations vetted for:
 - Diversity
 - Other committee service
 - Service generally limited to 2 concurrent committee appointments
- Nominations approved by Council
 - Appointments are typically for 3 years
 - Limit of two 3-year terms



Committee Service

- Committee meeting schedules vary
 - Typically meet monthly by conference phone
 - In-person meeting at annual conference
- Don't be passive!
 - Volunteer for assignments
 - Follow-through on assignments



Ad Hoc Committees and Task Forces

- Ad hoc committees
 - Shorter-term working groups intended to address specific issues and make recommendations to AAPOR's Council
- <u>Task Forces</u>
 - Longer-term working groups intended to address broad issues and make recommendations to AAPOR's Council

- The chapters are separate organizations, but they work with AAPOR to advance mutual goals
- Each chapter has its own members
 - Individuals do not need to be a member of AAPOR to join a chapter, and vice versa.
 - Individuals can join AAPOR and multiple chapters.
- Each chapter has its own elected leaders/officers
- Hold conferences, educational events, webinars, networking events, and student paper competitions

 - Usually fall/winter event at Princeton University and spring event at University of Pennsylvania

 - Host wide variety of workshops, panels, presentations, and networking events throughout the year

Affinity Groups

- Voluntary associations of AAPOR members who want to share ideas, information, and experiences with other members with similar affinities or interests.

Affinity Groups

- AAPOR members can form Affinity Groups around topics related to professional interests or personal affinities.
- To create an affinity group, anyone can submit an application to council that includes:

 - The group's purpose and the fundamental principles of the group's identity and operation
