Subject: Senate action that affects Census

Fellow AAPOR Members:

Here is a legislative matter of interest to AAPOR members:

This past week the Senate Appropriations Committee defeated an amendment that would have struck a provision in the disaster relief spending bill prohibiting the Census Bureau from using sampling in the 2000 Census. Since the provision remains, if the bill passes Census would not be able to use sampling to assess and adjust the undercount, and even, apparently, to implement the long form. A vote on the bill is expected this week. But, the President is expected to veto it. An account of this action appears in Sunday's New York Times, if you're interested in more information.

This week I will be in touch with COSSA and C-MOR, two organizations that lobby on behalf of social science, to learn what effort, if any, they have planned to deal with this provision. I will keep you informed of their actions. However, those of you who are concerned about the provision may want to contact your Senators about it.

This is a wonderful opportunity for someone who would like the opportunity and the resources to manage a center that can explore new ideas in survey research.

Position Available: Director of the UNH Survey Center

We are looking for a survey professional who will work with us to create and then manage a survey center for the 21st century.

The UNH Survey Center began operations on our campus almost 15 years ago. As a division of the UNH Institute for Policy and Social Science Research, it has grown to become an important and respected source of objective data about public opinion throughout the region. Our clients include corporate, government, and non-profit organizations. Our 20 CATI stations running CASES fulfilled almost \$350,000 of contracts during 1996. The staff has been comprised of a Director, Assistant Director, 4 shift supervisors, part-time financial and administrative assistant, and several dozen telephone interviewers.

Now we have the funds and the space to add major new capabilities to the Center. Over the next 18 months the center will move into a new facility, it will totally replace its current CATI system with hardware and software. John,

In a nutshell, here are the arguments for and against sampling in the Census. Census experts feel free to supplement/correct as needed!

Supporters and opponents of the provision of the bill prohibiting sampling in the 2000 Census divide along party lines. If Census uses sampling to adjust the undercount, it will likely benefit Democrats and hurt Republicans because the adjustment will add mainly poor and minority residents missed in the actual Census enumeration. Since the Census is used to allocate congressional districts, more poor people means more districts representing poor people.

I assume many members of AAPOR would oppose the provision because the long form of the Census provides statistical information that is useful to researchers-- a wealth of social and demographic data that is only collected from a sample of people enumerated in the Census. Without sampling, the long form would be gone, and with it all the detailed data.

I hope this helps you understand the issues involved.

Statistical Techniques for Market Research: Classification and Clustering

Census Bureau Allowed to Proceed With Sampling Under Senate Compromise

Revised Language Still Must Clear House/Senate Conference

The Senate today agreed to compromise language in an emergency spending bill that will allow the Census Bureau to proceed for now with its plans to use sampling in the 2000 census. The amendment offered by Senator Ernest Hollings (D-SC), and accepted by appropriations Committee Chair Ted Stevens (R-AK), as well as subcommittee Chairman Judd Gregg (R-NH), would prohibit the Census Bureau from making any "irreversible" decisions regarding the use of sampling that would affect the final population numbers used for apportionment.

The House has delayed consideration of the emergency spending bill until next week. While there is not similar census provision in the bill approved by the House Appropriations Committee, it is possible for a Member of the House to offer an amendment during floor debate. After the House completes action, the measure goes to a House-Senate conference committee, where differences between the two bills are resolved.

The new Senate language makes clear that any prohibition on sampling is not intended to stop the "long form," which goes to a sample of households and collects important demographic and socio-economic information used to implement Federal programs. The Senate Appropriations Committee had included language in the Fiscal Year 1997 Supplemental Appropriations bill, which primarily provides disaster relief for Midwest flood victims, that would have prohibited the Census Bureau from preparing to use any sampling in the 2000 census. The Bureau's current 2000 plan uses sampling to estimate the last, hardest-to-count ten percent of households, and then to measure and correct undercounts and overcounts.

In explaining the compromise on the Senate floor, Senator John Glenn (D-OH), ranking Democratic member on the census authorizing committee, said that there is no other way to get an accurate count than to use some sampling. A ban on sampling at this time, Glenn said, would be costly, since the Bureau has invested a lot of time and money to develop a sound design for 2000. The compromise, he pointed out, would "keep our options open," while also signaling "the seriousness of our concerns." Glenn opposed the use of sampling to adjust the census figures in 1990.

Senator Fred Thompson (R-TN), chairman of the authorizing committee, also supported the compromise. Thompson acknowledged that the sampling issue was not "easy to resolve." He expressed concern about the uncertainty surrounding the constitutionality and legality of sampling, and questioned the projected cost savings from sampling to complete the count. The burden is on the Census Bureau, Thompson said, to convince Congress and the public that its plan will be "fair and objective." Thompson called upon the Bureau to demonstrate that the use of sampling is "scientifically acceptable" and not subject to political manipulation.

On Tuesday, the Commerce Department's Inspector General said in a letter to Appropriations Committee Chairman Ted Stevens (R-AK) that carefully planned and implemented, sampling can be employed . . . to produce overall more accurate results than were produced in the 1990 census, at an acceptable cost." If the Census Bureau can't proceed to refine its proposed design for 2000, IG Francis DeGeorge wrote, the 2000 census would be left "in a most precarious position."

Committee roster change: Congressman Tim Holden (D-PA) has resigned from the Committee on Government Reform and Oversight to take a seat on another

committee.

Hearing update: The House Subcommittee on National Security, International Affairs, and Criminal Justice, of the Committee on Government Reform and Oversight, will hold a hearing to review the census long form, its effect on census participation, and proposed alternatives to meet the nation's data needs, on May 13, at 10 a.m., in Room 2154, Rayburn House Office Building.

Once you get to the Norfolk area, you want to take I-264 to the downtown/waterside area (eventually ending up across the river from Portsmouth). The hotel is right along the road you get dumped onto right after you exit I-264 at Norfolk, downtown. If you have a Norfolk map that shows the Nauticus center, the hotel is just a block or so away.

Having driven Rte. 13 (what Delawarians call the "Dual Highway") many times
from Philadelphia, let me say that folks coming from Philadelphia or points
north

**definitely* do *NOT* want to take I-95. It'll add about two hours to the
trip*

-- and be much less interesting!

>From north of Wilmington, DE: follow I-95 to the DE border, then skirt
Wilmington on I-495. A few miles after rejoining I-95, exit for Rte. 1
(also marked for Rte. 7 & Christiania Mall). Then stick with combination of
Rtes. 1 & 13 through DE (Rte. 1 is the beginnings of a DE turnpike that
[mercifully] by-passes Dover's strip development and race track). Toward
the southern edge of Dover, you must exit Rte. 1 and rejoin Rte. 13 via Rte.
10 (shortly after the \$1.00 toll). This is well marked, so should be no
problem.

After Dover, its Rte. 13 all the way to Virginia Beach, then I-64 (marked either for Chesapeake and/or Portsmouth, I believe) to I-264 -- which ends at Waterside Drive which, in turn, leads directly past the Marriott. (Just make sure you get Waterside and don't head for the tunnel!)

A word of warning: the whole Hampton Roads area offers miserable Washington-style traffic for rush hours. Avoid especially the 3-6P or 3-7P period.

Good luck to those of you making the trek down the Eastern Shore. Enjoy the rural scenery!

As a native Delawarean, I agree with Roy Reese that traveling Routes 1 and 13 is the way to go to Norfolk from Wilmington and points north.

Two warnings, however: The bridge connecting Route 13 with Virginia Beach is a long one and has a large toll (between \$10 and \$20, I think). So if you take the scenic route, make sure you have lots of cash (these are rural areas where ATMs are not easily available). And if your stomach can't take the thought of driving without seeing very much land for minutes at a time, use I-95 and I-64 instead.

Could I get some information on best practices in handling answering machine calls? The problem is repeated calls to Answering Machines and complaints by respondents as they see a lot of callbacks in their caller ID. In fact the problem is with any repeated call backs identified by respondents with caller ID equipment on their lines. Thanks. Regards.

We have struggled with this issue in our RDD calls, as it could be frightening to people to have a lot of hangups on their answering machine (or if they are screening their calls). (We block caller ID when we call since the interviewers often call from their own homes.)

We have used the following approach for about a year, which is reasonably successful. At the third attempt where there is no answer (first attempts are always in the daytime on a weekday, second is evening, third is weekend), we leave a very brief message identifying the purpose of the call and the caller and saying when we are calling back. The message also leaves a number that the respondent can call to verify the legitimacy of the study. Another message is left on the fourth call -- we have found that the respondents are often screening their calls and will pick up the phone when they hear this second message. We usually do not leave messages if there is no answer on the 5th-9th call. We abandon the number after 9 attempts. A few times, people have changed their answering machine message to respond to us! Our interviewers feel that this approach has worked out well in metropolitan

areas, but has not been as successful in other areas.

We also do call backs on all phone numbers where an answering machine is reached at all nine attempts. We use the same procedure for these calls as we do for the respondents who refuse to answer the screening questions or refuse to participate. A second series of nine calls are made 3-4 months after the original call by a different interviewer. If the number is answered, the interviewer first verifies that the respondent had that phone number at the time of the original call. If so, then the respondent is screened according to protocol. We resolve about 1/2 of all of the numbers that were "answering machine" on the first series of calls in this manner (we also turn around about 1/2 of the refusals). We were surprised at this, but it seems that some people who screen their calls with an answering machine do not always screen. This has helped us keep our response rates high. Since we use RDD to recruit controls for our population-based epidemiologic studies, it is worth all of this effort to increase the likelihood that our control groups are representative of the population of interest. This level of effort may be unreasonable for market research.

Interestingly, this is still a topic of some concern, although Mattell and Jacoby years ago in the Journal of Applied Psychology did not find improvements in reliability when increasing the number of scale points. Miller's paper on the number of types of information (five plus or minus two, if I remember the essence) said about the same. My own dissertation, Goldsamt, 1971 and in a paper at the Southwestern Psychological Association conference the next year, showed that when comparing 6, 12, and 18 point rating scales, and controlling for scale content--- the amount of extreme response style bias or response set did not increase with the number of scale points.

I generally have found in my work (designing attitude surveys in organizational climate and program evaluation settings) that the number of points generally hovers at five points, with very little gained by using seven and certainly not with 10 points. A database I've built of response formats used by a number of sources seems to go very rarely above 7 points. There may be, however, some improvement based on the particular issue being rated, and the ability of raters to sufficiently differentiate levels of the particular attribute or response domain.

Related to this, I just wrote Ford Motor Company and pretty much put down their customer satisfaction survey format of a 10 point scale, but really having 5 groups of two points each, as confusing and unreliable. [This was in the style of: "Very Much" representing points 9 and 10, "Moderately" represented by points 7 and 8, etc.]

I suggest that Dr. Jon Krosnick at Ohio State Univ. and Dr. Norbert Schwartz at Univ. of Mich. (if I have his affiliation correct) be contacted, as doing research in the utility of various rating scale points. I intend, though, to look into Dr. Bryant's recommendation.

Aside from the usual set of problems, I am particularly disturbed by the new spate of "surveys" that are being fielded over the world wide web. Hardly a day goes by that I don't see an announcement to some netnews group or list server asking people to "please answer my survey". Similarly, many commercial sites regularly include links to customer feedback forms that they advertise as surveys. There is next to no recognition of the most elementary issues in sampling, and the boundaries between research and marketing quickly get very blurred.

It is relatively easy to place a questionnaire on the web. The numbers of people who see such requests are often quite large, and the few hundred self selected responses often appear to be a large "representative" group to the uninitiated.

As more and more commercial transactions take place over the internet, there will be more and more need for legitimate survey research in that venue. The good news is that we _can_ figure out how to deal with sampling issues. The bad news is that all of the usual problems with misconstrued surveys, many of which are now well handled by AAPOR and other professional groups, will recur and be compounded on the internet.

Controversy Over Census Sampling Language in Spending Bill Remains
Unresolved; House-Senate Negotiators Fail to Reach Agreement Before Holiday
Break

A House-Senate conference committee negotiating differences in a spending bill primarily aimed at providing disaster relief for the flood-stricken Midwest failed to agree on language that would let the Census Bureau proceed for now with plans to use sampling in the 2000 census. Congress heads home today for a week-long Memorial Day break.

Yesterday, Rep. Carolyn Maloney (D-NY) and Rep. Christopher Shays (R-CT), co-chairs of a newly-formed Congressional Caucus on the Census, circulated a letter to their House colleagues, asking them to sign a letter urging the conferees to abandon the effort to prohibit sampling on an unrelated

spending bill. Maloney and Shays noted that the congressional oversight committees have not yet completed their own review of the Bureau's plans for 2000. The deadline for signing onto the conferee letter is Wednesday afternoon, May 28.

The Senate version of the FY97 Supplemental Appropriations bill includes a provision prohibiting the Census Bureau from making any "irreversible" decisions regarding the use of sampling in the 2000 census. The language is limited to sampling methods that would affect the population counts used for congressional apportionment. The House version contains no census language. Senior House Republicans are quoted in several Capitol Hill publications as saying that the leadership is pushing for a strict ban on sampling during the conference on the spending measure. The Senate is scheduled to reconvene on June 2, the House on June 3.

Stakeholder activities: On May 29, the Census Bureau will host the 1997 National Conference on Census 2000 Partnerships at the University of Maryland campus in College Park. The day-long conference will provide an opportunity for national and community organizations to share their ideas for making the 2000 census a success, and to learn more about how they can work with the Bureau to encourage participation in the 2000 census. While many organizations have registered for this important pre-census meeting, there is still room for additional participants. Please call Barbara Harris at the Census Bureau immediately if you would like to attend the conference and have not yet registered. Ms. Harris can be reached at 301/457-1305.

The 2000 Census Advisory Committee to the Secretary of Commerce will hold its quarterly meeting on Friday, May 30, also at the Inn and Conference Center at the University of Maryland, from 8:45 a.m. - 4:30 p.m. The

committee will discuss recent developments in the review of the Federal race and ethnic categories; the status of the questionnaire content determination process; and the Census Bureau's partnership efforts with governments and community groups. (Please note that this meeting originally was scheduled to run for two days.)

I hope asking two general survey research questions in one day does not violate a norm (or unnecessarily clog up subscribers' e-mail boxes).

Does anyone have experience with (or recent citations of) the use of magnitude estimation questions? We are designing a survey to measure a respondent's annoyance with a specific type of noise (such as noise from aircraft takeoffs and landings from a nearby airport), and are looking for additional ways to evaluate the level of annoyance. We are contemplating a magnitude estimation question that would ask respondents to compare (and quantitatively rate) their level of annoyance from noise attributable to aircraft takeoffs and landings in relation to a list of other commonly experienced sources of noise (lawnmowers) and other annoying things that are not related to noise (finding litter in your front yard). I am interested in finding out about others' experiences in designing and administering these types of questions, as well as how useful they were in the final analyses.

I have seen the little green Sage Publications booklet on magnitude estimation, but was wondering if there were other examples of how these types of questions are used out there.

I responded a little while ago that SAS Institute, Cary, NC uses this approach annually in its Software Users Ballot. They're at:

<http://www.sas.com/>

They ask respondents to allocate \$500 to any of the listed future software enhancements they are considering. A little amount of money indicates little desire for that specific feature being added to the SAS software package, while a larger allocation indicates much more interest in having that feature added. If more than \$500 is allocated, then the total amount of money allocated is scaled back to \$500. Respondents are told that that will happen.

I surmise they analyze the data by obtaining mean allocation amounts by specific feature (and some years there have been over 150), and rank ordering them from highest (greatest interest among the self-reporting respondents) to lowest (least interest). I also surmise they need to consider the costs (programmer and systems analyst time), and systems compatibility, etc factors before they agree to follow what the pattern of votes indicate.
